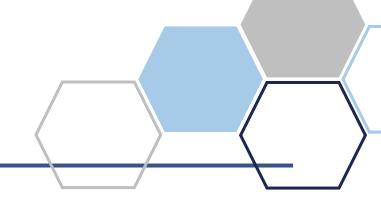

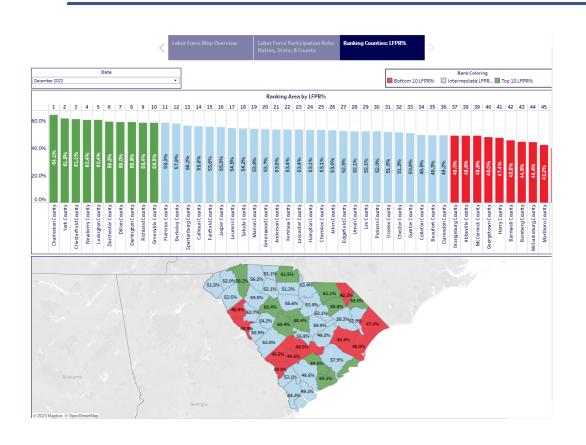
### **Activity Since January 2023**

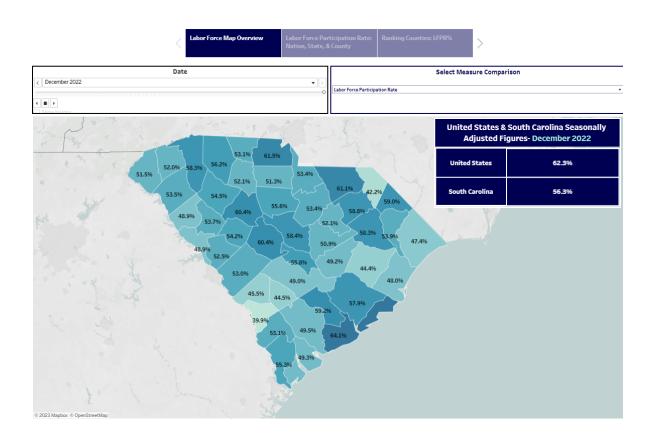


- January and February Briefing Session
  - More that 260 total attendees across all four sessions
  - Almost 60 views of the recording posted online
  - Themes emerging from comments
    - Impact of inflation on pay
    - Definition of "higher pay"
    - In and out migration of workers
    - LFP across demographics including gender, race, veteran, offender
- Created LFP tools
- Continued to present findings of Task Force to stakeholder groups

### Where did it come from?

#### September 2022 through January 2023

- Committee meets for several months
- Receive information/testimony from...
  - state agencies,
  - industry associations, and
  - individual businesses.







### The purpose of the bill is to...

Coordinate various workforce development services across the state,

(Dream Team playing together)

Centralize oversight of these entities, and

(Office of Statewide Workforce Development)

Ensure an easy to access, customer-centric workforce system.

(Single portal, continuous collaboration with industries, etc.)



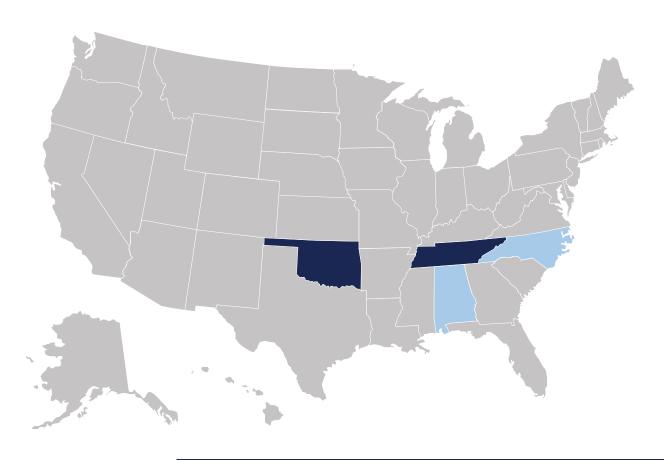


### Setting a Labor Force Participation Rate Goal

H.3726 would place this responsibility under CCWD if passed.

Similar efforts are being undertaken by several states in the region:

- Alabama
- North Carolina
- Oklahoma
- Tennessee





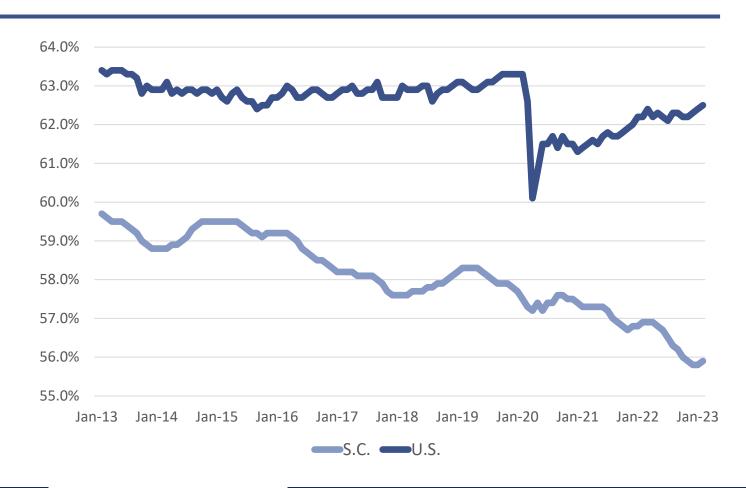
### Labor Force Participation Goals in Other States

- Alabama: "adding 500,000 credentialed Alabamians to the labor force"
- North Carolina: "By 2030, the goal is to have 86% of 25- to 44-year-olds participating in the labor force."
- Oklahoma: "Increase Oklahoma's labor force participation rate from 60% to 65%."
- <u>Tennessee</u>: "increase labor force participation rate to 65% by 2025"
- None of these goals appear to be empirically driven.
- There are at least three different approaches here.



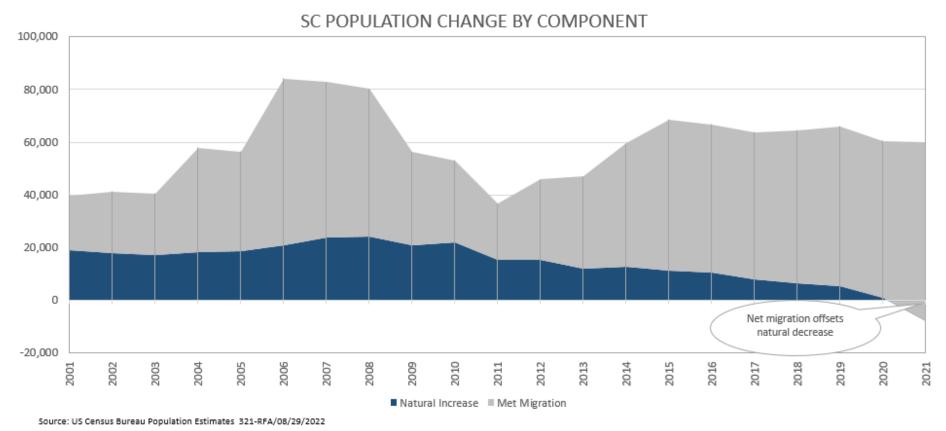
## Labor Force Participation Rates by Age Range, 2022

- Overall: 56.3%
  - 4<sup>th</sup> lowest in nation
- Age 25-34: 80.4%
  - 9th lowest in nation
- Age 35-44: 80.9%
  - 7<sup>th</sup> lowest in nation
- Age 45-54: 74.3%
  - 5<sup>th</sup> lowest in nation
- Age 55-64: 58.8%
  - 8<sup>th</sup> lowest in nation





### Components of Population Change



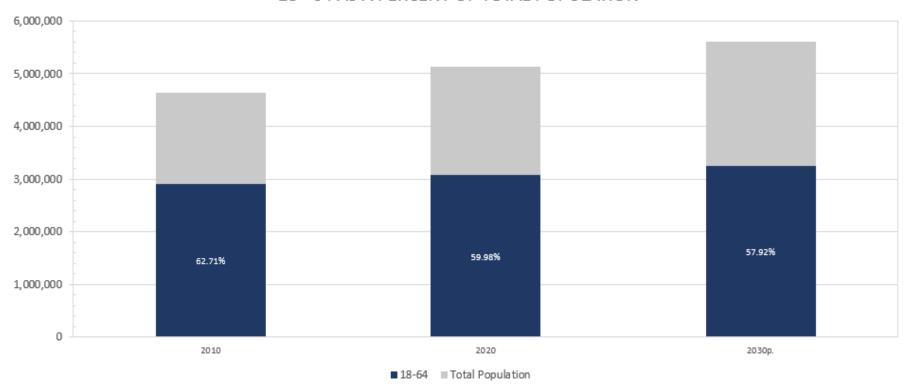
Natural Increase - the number of births minus the number of deaths

Net Migration - the number of people moving into the state minus the number moving out



## Projected Working-Age Population Share

#### 18 - 64 AS A PERCENT OF TOTAL POPULATION









- 1. Should the target be overall LFPR or some subgroup of participants?
  - Age ranges?
  - Demographic groups?
- 2. What other factors should be considered when setting a goal?
  - In-migration patterns?
  - Aging patterns?
  - Fertility trends?
- 3. BLS publishes statewide LFPR monthly basis and subgroup participation rates annually.
  - Does this impact the goal South Carolina should set?
  - Are there other data sources that should be considered, even if they are experimental or unofficial?
